Master Services Agreement required

MONTHLY SUBSCRIPTION

Season commitment — billed monthly

- Use as two 60-minute or one 120-minute session
- Unused sessions roll over one month (4 max)

ADD-ONS & PARTNERED EVENTS

Add-ons. À la carte hours and packages may be added to a Season Pass or Subscription at any time, including after a program balance is used. Active Season Pass and Subscription holders receive **15% off** à la carte hours, camps, workshops, clinics, intensives, and competition prep.

Partnered & team events (Duo Interpretation, Public Forum, Policy, and similar). All participants must be APS clients. 90-minute minimum session; each participant is charged 66% of the session length — a 90-minute session bills **1 hour to each participant's account**.
